**\*Borrowing a Stafford loan for the summer will reduce the amount available to borrow for the fall 2012 and spring 2013 semesters. Undergraduate students may borrow up to half of their maximum annual loan amount in the summer. Example: Junior/Senior can borrow up to \$3750 for summer (\$7500/2=\$3750).**

NOTE: To be considered for Federal aid, you must have a valid 2012/13 FAFSA on file with the Office of Financial Aid. Pell eligible students will be automatically considered for Summer Pell. Summer Pell may reduce your spring 2013 award. **YOU MUST BE ENROLLED AT LEAST 6 CREDIT HOURS FOR THE SUMMER TO OBTAIN A FEDERAL DIRECT STAFFORD LOAN.** If you do not enroll for the requisite number of credit hours, your loan will be canceled. You will be responsible for any outstanding bill with the college.
