First and Only Reading

Kaitlin: This committee allocates research and travel grants through the Department of Sponsored Research; there is a cap of \$600 that can go towards any student that applies for funding for academic research or to travel to a conference to research or present their research. Student Association funds this entity in large part, which is why two members of the SA Executive Committee serve on it. Zarmeen works in the Department of Sponsored Research and is well-versed in this area, and can be a voice for students when allocating money.

Kaitlin: The Student Court is a body that exists in case there are issues that come before the Student Association so that the issues can be evaluated and voted on. Applications have gone out to those interested, and the body can consist of up to five people. With one acting as the Chief Justice, which is a position maintained for the entirety of a student's undergraduate career at Geneseo. Many are freshmen and sophomores, which is to ensure consistency until they are seniors and competence, given that they will serve for several years.

Second of Two Readings

Corey: Peer Advisement deadline has been modified so that forms must be turned in three days prior to Peer Advisement events, which are a way for academic clubs to provide guidance to students regarding what those clubs specifically touch on. Much of it has to do with registration for classes, tips on professors, and research opportunities within a major. The bigger change is a removal of a penalty that would decrease the amount of money a club could ask for if they already had Bad Financial Standing, which was already a two-week penalty applied for missing an SA meeting (which could be removed if the club attended the next two meetings). Corey views the penalty as aggressive towards clubs and making them less likely to ask for funding.

Zach asks for an explanation for the 3-day deadline of handing in the Peer Advisement form. Corey says that previously, clubs were given a week after their events to hand in Peer Advisement forms. The new deadline allows SA to hold clubs accountable for being prepared for their events, and allows SA to continually advise clubs. The new deadline a good middle ground in terms of time.

Alberto: The Alliance for Community Enrichment is asking for a deadline extension because tickets at the Geva Theater were not available until October.

LSA Representative: LSA asks for fundraising approval so that extra funds can go towards improving club events this year, which include dance performances.

Supriya explains that usually, fundraising is approved by SA before a fundraiser is held, but due to an administrative error this did not happen. She asks that whoever is listed as the presenter on the fundraising form be present at the meeting to present. A rep asks for clarification regarding whether clubs need SA's permission to fundraise. Kaitlin explains protocol to apply for fundraising approval.

17-1718, First and Only Reading, Passes 6-0-1, Supriya abstaining.

First and Only Reading

Supriya: The Finance Committee will now approve fundraising requests. There will be a roughly 2-week turnaround period: requests will go to Student Life, then to Finance Committee for approval, after which clubs will be allowed to fundraise.

Zach asks why there are three voting members. Kate explains that financial policy dictates a minimum of three voting members, with Supriya abstaining from voting.

Zach asks how the committee was selected. Supriya had Financial Committee applications out since the beginning of the Fall semester, and three applicants had previously been on the committee, which is why they were made voting members.

19-1718 BE IT RESOLVED THAT THE SA EXECUTIVE COMMITTEE allocate up to \$658. 89 from Budget Increases, account 1099, to Men's Rugby, account 1405, to fund upcoming conference dues, gas reimbursements and equipment.

First of Two Readings

Graham: \$350 of the increase will go towards conference dues; the team must pay \$800 total to the Upstate New York Collegiate Rugby Conference and currently only \$450 of funds are free to go towards dues. Rugby also asks for \$100 increase in gas reimbursement fund for one more in-season game, and most likely two or three more playoff games afterwards. The remaining funds will go towards team equipment: 6 training balls, 2 match rugby balls, 2 training ladders for agility practices, and 100 orange cones.

Alberto asks for rationale behind budget increase. Graham explains that he did not turn in Rugby's budget proposal on time last year, which resulted in the team's funding being cut, and the team running on inadequate funds this year.

Zach asks whether the team does not already have ladders and cones for practices. Graham responds that it does not.

Supriya asks how many days it took for the budget to be handed in last year. Graham responds that it took eight days, which resulted in an 80% budget cut of the team's funding. Supriya asks how many people are actually driving who would need to put in purchase orders. Graham responds that there are usually between 8 and 10 cars driving to each game.

Corey asks whether Rugby has considered fundraising in light of their budget being cut. Graham responds that they have, but given that the season is well underway, money is needed by October 13th to pay for conference dues, and in the future they will consider fundraising. Corey asks about urgency of acquiring funds. Graham explains that a \$150 late fee will be incurred if conference dues are not paid by October 13th, which Rugby does not wish to pay out of pocket, and the equipment is urgent because the team is practicing with inadequate equipment at the moment.
