Teacher candidates are expected to integrate technology in their lessons as they progress through their coursework. In all courses, teacher candidates use the SOE standard lesson plan which requires the integration of technology into each lesson. During coursework at the initial level, the use of technology is modeled in courses starting with INTD 203 (Block 1) - Social Foundations of Education in the US. As candidates progress through the blocks that culminate in student teaching, they are expected to continually improve their ability to integrate technology into their lessons and curriculum. This requirement spans certification areas. In the Social Foundations of Education in the US course, which is required in all initial preparation programs, teacher candidates are fully immersed in the use of instructional technology in a course that later leads to field work. Teacher candidates are asked to incorporate technology and reflect on their choices as part of coursework that is integrated within their field experiences in CURR 316 or EDUC 204/206. Item 3b on the assignment rubric "Integrating and Applying Instructional Technology," measures this. Instructors scored 64.5% of candidates Distinguished (3 out of 3) and 27.9% Proficient (2 out of 3) for a combined 92.4%. All candidates are also required to complete a technology-based lesson plan during student teaching which is evaluated by both the cooperating teacher and university supervisor. To further strengthen the connection between school partners and the SOE, certain class sessions of 213/316 and 313/317 take place at partner school sites to allow for cooperating teachers to attend and gain knowledge on new technological applications. The rating that undergraduate student teachers receive while student teaching is reflective of the instruction and practice they have completed in prior semesters. Student teachers are rated highly on the use of media and technology as reflected below: Criterion 25 is "intentionally engaging students in the effective use of technology." Evaluators rated 48.0% Distinguished (3 out of 3) and 50.2% Proficient (2 out of 3) for a combined 98.2%. In our advanced program, candidates have engaged students in creating wikis,

blogs, podcasts, imovies, prezi, short videos through the app Clips, and stop-motion animation. Candidates have asked students to make recordings using Garageband. Also in our advanced program, candidates have the opportunity to work with technology at multiple points during their coursework. Candidates work to reach this goal through time spent working with students during literacy clinics in high needs areas including Avon, NY and Rochester, NY. These clinics provide exposure to different educational contexts while allowing SUNY Geneseo students the opportunity to integrate technology lessons they have learned in the classroom.

Teacher Training

a. Teach students with disabilities effectively

The coursework in all our education programs are attentive to multiple forms of diversity, as a survey of program course instructors has shown. Furthermore, we attend specifically to disability in, for instance, our teaching & use of Universal Design for Learning in the lesson plans our students use in program courses. All candidates are now required by state regulation to spend a minimum of 15 field hours working with students with disabilities. Students in each major (Early Childhood, Childhood with Special Education and Adolescence) all receive training in working with students with special learning issues. In our program there is a specialized class that deals with characteristics, behavior, and assessments. While not all field visits include students with IEPs, in most of the classrooms a number of students are in the process of being observed & assessed with an eye to possible future classification, and/or are being supported by teacher aides, specialized staff (e.g., OTs, PTs, speech), and/or consultant teachers. The teacher candidates draw on their coursework and field visits to reflect on how well these settings support the education of all students, but with a primary focus on students who have learning challenges.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

This rarely happens, except for Childhood with Special Education candidates, but occasionally our non-Special Education student teachers are able to sit in on CSE, CPSE, or PST meetings.

c. Effectively teach students who are limited English proficient.

The first undergraduate literacy course, CURR 213, provides introductory instruction on working with multilingual learners such as English Language Learners (ELL) and providing English as a New Language (ENL) specialized instruction. In January 2020, the literacy faculty met to add a major focus to CURR 213 on assessment and instruction of Tier 3 struggling readers, including students with dyslexia. At the same meeting, the faculty added a major focus on English Language Learners and English as a New Language instruction to the second undergraduate literacy course, CURR 313. Full implementation occurred in all course sections during the Fall 2020 semester. Classroom Management for Early Childhood Education, EDUC 326, taken by Early Childhood majors, contains modules on working with culturally and linguistically diverse parents and culturally responsive practices -- including a focus on culturally responsive positive behavior interventions and supports.

Starting with Intro to Special Education in Block I candidates start working with children with disabilities. In Block II, SPED 224 candidates spend 25 hours in the field and they get the chance to teach a lesson to an inclusive classroom. In Block IV candidates do behavioral observations as part of the

practicum hours . Block V has 25 hours where candidates are placed in a special education setting and have a chance to co-teach with a special education teacher. They also have the opportunity to work on an assessment project.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students in the SPED 383 class work on a case study IEP as part of the class and this is a key assignment. During student teaching, students who are in the Childhood/Special Education get the opportunity to work on an IEP - and if they are in the placement and their IEP meetings candidates get the opportunity to participate in the meetings.

c. Effectively teach students who are limited English proficient.

The two literacy courses, CURR 213 and 313, for which attention to Tier 3/readers with dyslexia and multilingual learners is described in section (a) above, are required for both elementary education and special education majors. Additionally, special education candidates take coursework in high incidence disabilities, which includes modules on teaching methods for culturally and linguistically diverse exceptional learners (SPED 372). Coursework in assessment, SPED 382, incorporates considerations and best practices for assessing students who are English learners. SPED 385, which focuses on collaboration and co-teaching, provides ample background skill development for novice teachers who will be within the current general education classroom collaboration model in NYS for providing ESOL services to students who are LEP.
